INSTRUCTIONS

- 1. Pursuant to the provisions of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014, assent or dissent of the members in respect of the Resolution contained in the Postal Ballot Notice is being sought through Postal Ballot process.
- 2. A member desiring to exercise his/her vote by Postal Ballot, may send duly completed form in the enclosed self addressed Business Reply Envelope. The envelope bears the name of Dr. S. K. Jain, Practising Company Secretary appointed as the Scrutinizer by the Board of Directors of the Company.
- 3. Postage on the Business Reply Envelope will be borne by the Company. However, envelopes containing Postal Ballot, if sent by courier or by Registered Post at the expense of the member will also be accepted. The Postal Ballot(s) should be deposited at the Scrutinizer's address at Dr. S.K. Jain, Practising Company Secretary, 13/16, Kapadia Chambers, Ground Floor, 599, J.S.S. Road, Chira Bazaar, Mumbai 400 002.
- 4. The envelopes containing the Postal Ballot should reach the Scrutinizer not later than the close of business hours i.e. 5:00 p.m. on Thursday, the 1st day of December, 2016. A Postal Ballot Form received after this date and time will be strictly treated as if the reply from the member has not been received.
- 5. A Member has to convey his/her assent or dissent in the Postal Ballot Form only. Assent or dissent to the proposed resolutions may be recorded by placing a tick mark (√) in the appropriate column. Postal Ballot Form bearing (√) mark both the column will render the form invalid.
- 6. The Postal Ballot Form should be completed and signed by the Member. An incomplete, unsigned, incorrectly completed, incorrectly ticked, defaced, torn, mutilated, over-written, wrongly signed Postal Ballot Form will be rejected.
