## INFORMATION REGARDING 36TH ANNUAL GENERAL MEETING, E-VOTING AND BOOK-CLOSURE

The 36<sup>th</sup> Annual General Meeting ("AGM") of the Company is scheduled to be held on **Tuesday, September 23, 2025 at 12:30 PM**, through Video Conferencing/Other Audio Visual Means ("VOCAVM") to transact the business set out in the Notice convening the AGM. Members will be able to attend and participate in the AGM through VOCAVM facilities.

Ministry of Corporate Affairs ("MCA") vide its Circular No. 20/2020 dated 05<sup>th</sup> May 2020; 10/2022 dated 28<sup>th</sup> December, 2022 (collectively known as the "Circulars") and the Securities and Exchange Board of India vide its Circular No. SEBI/HM/MD/IR/SEB/PO/PIR/2023/24 dated 05<sup>th</sup> January 2023 has allowed intra-annual AGM through Video Conferencing/Other Audio Visual Means ("VOCAVM") without the presence of physical members at a common venue; in accordance with the aforesaid circulars.
